Guide to Fill the Samco Account Closure Request Form

This form is used to close your Trading + Demat account with Samco. Please follow the steps carefully:

Step 1: Account Holder's Details

- DP ID & Client ID (BO ID) → You need to fill this. It is a 16-digit number:
 - o First 8 digits = DP ID
 - Last 8 digits = Client ID (BO ID) You can find this in your demat account details.
- Name of the First/Sole Holder → Write your full name (as per records).
- Name of the Second/Third Holder → Fill if applicable, otherwise leave blank.
- Address of Correspondence → Write your registered address.
- City, State, Pin → Fill in your city, state, and pin code.

Step 2: Balance, Security Details & Reason for Closure

- Reason for Closing the Account → Clearly write your reason (e.g., not using, shifting to another broker, service-related issue, etc.).
- Balance remaining in the account (if any) → Tick the correct option:
 - \circ Rematerialized \rightarrow If you want physical shares back.
 - Transferred to another account → If you are moving holdings to a new demat account.
 - Partly Rematerialized and Partly Transferred → If some holdings are to be converted into physical form and some moved to a new demat account.
 - \circ Not Applicable \rightarrow If there is no balance in the account.
- For "Balance present in a/c" → Tick the applicable option (ear-marked, pledged, etc.)
 or leave blank if not applicable.

New Demat Account Details (if transferring holdings)

If you choose Transferred or Partly Rematerialized and Partly Transferred, you must also provide:

- DP ID of the new account
- Client ID of the new account



Step 3: Declaration & Signature

- Sole/First Holder must sign in the space given.
- If joint holders exist, they must also sign.

Step 4: Trading Account Closure Form

- Name of Client → Your name (same as earlier).
- Trading KYC Code (Client ID given by Samco) → Mention your Samco Client ID (e.g., DP12345).
- Segment of Closure → Tick which exchanges you want to close (BSE, NSE, etc.).
- Reason for Closing Account → Tick your reason (e.g., Service issue / Shifting to competition / Not interested).
- Signature of Client → Sign again here.

Step 5: Acknowledgement Receipt (Office Use Only)

This section is for Samco's office use. You don't need to fill anything here.
