Guide – Bank Account Modification in Demat/Trading Account

This form is required when you wish to modify or add bank account details linked with your Samco Trading/Demat account.

Step 1: Date & Basic Details

- Write the Date in DD/MM/YYYY format.
- Client Code → Write your Samco Client ID (Trading KYC Code).
- CLID → You need to fill this. It is a 16-digit number:
 - o First 8 digits = DP ID
 - Last 8 digits = CLID You can find this in your demat account details.

Step 2: Account Holder's Details

- Fill the Name of First/Sole Holder (as per records).
- If applicable, also fill Name of Second Holder and Third Holder.

Step 3: Mention the Change

- In the Details section:
 - Tick Change in Bank Account Details.
 - Under "Addition / Modification" → write whether you are adding a new bank or modifying existing details.
 - Fill in: Existing Bank Details (your current registered bank).
 New Bank Details (bank you want to add/update Account No., IFSC, MICR).

Step 4: Signature

- First/Sole Holder must write:
 - o Full Name (same as in records).
 - o Signature.
- If joint account → Second & Third holders also need to sign.

Step 5: Attach Documents (Mandatory)

When submitting the form, attach any one of the following documents for the new bank account:

- 1. Cancelled Cheque with your name printed on it
- 2. Latest Bank Statement showing:
 - Account Number
 - o IFSC Code



- o MICR Code
- o Account Holder's Name

Step 6: Submission
