Guide to Fill the Samco Nomination Form

Step 1: Date

- Write the current date in DD/MM/YYYY format at the top of the form.

Step 2: UCC / DP ID & Client ID

- Enter your UCC / DP ID (16-digit number).
- Enter your Client ID (as given by Samco).

Step 3: Nominee Details

- In Details of 1st Nominee:
 1. Name – Write the full name of the nominee.
 2. Share of Nominee – If there is only one nominee, mention 100%. If more than one, divide the share (e.g., 50% - 50%).
 3. Relationship – Mention relationship (e.g., Father, Mother, Sister, Spouse, etc.).
 4. Address – Write complete address of the nominee (building, road, city, state, pincode).
 5. Mobile Number – Provide nominee's contact number.
 6. Email ID – Mention nominee's email ID.
 7. PAN / Aadhaar – Provide nominee's PAN/Aadhaar number.

(Repeat the above if you want to add 2nd or 3rd nominee, otherwise leave blank.)

Step 4: Minor Nominee (if applicable)

- If your nominee is a minor (below 18 years):
 1. Fill in Date of Birth of the minor nominee.
 2. Provide Guardian's details – Name, Address, Mobile, Email ID, Relationship with Nominee.
 3. Tick the appropriate Guardian Identification proof (PAN, Aadhaar, etc.).

Step 5: Account Holder Details

- At the bottom of the form:
 1. Write your full name in the "Name(s) of holder(s)" section.
 2. Put your signature exactly as per Samco records.

(If there are joint holders, Second & Third Holder must also sign.)

Step 6: Submission

- Once completed, submit the duly filled and signed form to:
